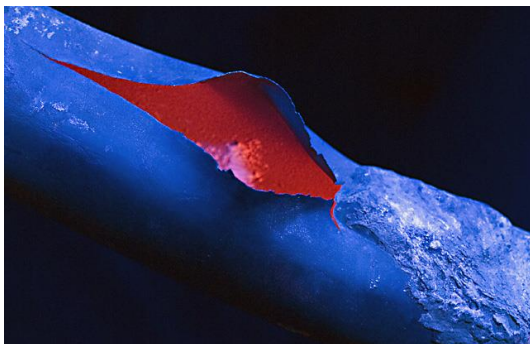
Greetings from CAG!
