Facts

1. <u>Coal handling</u> is the initial process in a coal-based thermal power plant which functions to receive, process, and store coal, and feed the coal bunkers over the lifespan of the plant.

2. The <u>boiler</u> is a closed vessel in whose shell and tube, water and hot gases simultaneously flow, to facilitate the transfer of heat from one to another. The efficiency of a boiler depends on various factors including its design, heat cycle employed, built-in losses, heat lost to flue gases, properties of water and hot gases.
